MOTION TO COMPEL COMPLIANCE WITH SETTLEMENT AGREEMENT AND FOR SANCTIONS

COMES NOW the Plaintiff, BARBARO R. DAVILA, by and through his undersigned counsel, and pursuant to the parties' January 12, 2009 JOINT MOTION AND STIPULATION FOR APPROVAL OF SETTLEMENT AND FOR DISMISSAL WITH PREJUDICE(D.E.49) (the "Stipulation) and this Court's January 15, 2009 ORDER OF DISMISSAL (D.E.50) moves this court to compel Defendant, AWARE DIGITAL, INC., to comply with the aforesaid stipulation and for an award of his attorneys fees as a sanction under F.R.Civ.P. 70(a) for having to file this motion and as grounds for the motion states:

- 1. The parties amicably agreed to resolve this matter at mediation and proceed to commemorate said compromise via the Stipulation.
- 2. The Stipulation was filed on January 15, 2009 and that same this Court issued its order of dismissal.
- 3. To date, Defendant has failed to pay Plaintiff the agreed amount settlement monies notwithstanding numerous attempts by Plaintiff's counsel to obtain the settlement monies from Defendant. See attached composite Exhibit "A".

- 4. The Stipulation reads, in pertinent part, as follows:
 - 7. It is further agreed and understood that Defendant shall, within ten (10) days of receipt by Defendant's attorney of a fully executed settlement and general release agreement, forward the settlement proceeds, which shall be held in Plaintiff's counsel's escrow and/or trust account and such funds shall not be released until January 9, 2008 and receipt Court approval of the settlement agreement and dismissal of the above-styled cause of action with prejudice, to Jose Antonio Llerena, Plaintiff's attorney as follows:
 - (a) One thousand eight hundred and two dollars and forty-two cents (\$1,802. 42) will be allocated as payment for Plaintiff's claims in the civil action, which represents back pay, overtime compensation
 - (b) Eight thousand one hundred ninety-seven dollars and fifty-eight cents (\$8,197 58) will be allocated as payment for Plaintiff's claims for attorney's fees and costs, made payable to Jorge L Fors, P A
- 5. All the conditions mentioned in paragraph 4 above have occurred, except Defendant's payment of the settlement funds.
- 6. Plaintiff has expended time and effort in preparing and filing this motion and respectfully prays for an award of his attorneys fees as a sanction under F.R.Civ.P. 70(a) for having to file this motion.

WHEREFORE, Plaintiff, BARBARO R. DAVILA, respectfully requests this Court to grant the relief requested herein.
